Lee will ask Andrew Teal if he would be available/interested in training. volunteers will be needed on the boat when collecting milfoil, boaters/kayakers needed when collecting curly pond weed. Job description needs to be written and advertised on the Town website. Chris will look into a designated AIS fund in the town budget for depositing the donations made to the activities of AIS and investigate how the grant money is recorded.

Matt Berg Survey Results (Tomahawk, Sandbar, George) – Ingemar, Gus, Lee Tomahawk Lake – eurasion milfoil bed has expanded along the northern shoreline, the beach, and a new bed appeared in a pocket on the south shore. Sandbar Lake, the mill foil has expanded but it's dispersed around the lake. No milfoil found on George Lake. Reports prepared are filed at the Town of Barnes and will be available on the website
