## RIDE PUBLIC TRANSIT ROUTE IN SOUTHERN BAYFIELD COUNTY

Bayfield County Department of Human Services and Namekagon Transit are proud to offer a public transit route to serve the southern part of Bayfield County. This service operates one day a week (Tuesdays). It originates in the Barnes area; serves Drummond and Cable, and continues into the Hayward area.

Passengers will then have the ability to transfer to a circulator route in Hayward and travel from store to store as well as the Court House and medical facilities.

Senior Citizens or persons with disabilities receive a 50% discount; the per trip cost is .50 cents. The schedule follows and will be adjusted if necessary. Reservations are not necessary, but are appreciated.
